



## PRIVACY POLICY

Information on the processing of personal data on the website *pursuant to Art. 13 and 14 of EU Regulation 2016/679 (GDPR)*

Dear Visitor,

VALLAND S.p.A. (hereinafter "Valland" or "Data Controller") informs you that the personal data collected through the website **www.valland.it** will be processed in compliance with EU Regulation 2016/679 ("GDPR") and Italian legislation on personal data protection.

This privacy policy describes how personal data of users who visit the website and/or interact with the services accessible through it is processed.

### 1. DATA CONTROLLER

### 2. CATEGORIES OF DATA COLLECTED

The website may collect the following categories of personal data:

#### 2.1 Browsing data

The IT systems and software procedures used to operate this website acquire, during their normal operation, certain data whose transmission is implicit in the use of Internet communication protocols:

- IP addresses or domain names of the devices used
- URI (Uniform Resource Identifier) addresses of requested resources
- Time of the request and method used
- Browser type and operating system
- Other parameters related to the operating system and user's IT environment

This data is used exclusively for technical purposes (website operation, anonymous usage statistics) and is retained only for the time strictly necessary.



## 2.2 Data voluntarily provided by the user

The optional, explicit and voluntary sending of messages via the contact form or emails to the addresses indicated on the website involves the acquisition of the data provided by the user:

- First and last name
- E-mail address
- Phone number (if provided)
- Company and role (if provided)
- Message content and related attachments

## 3. PURPOSES AND LEGAL BASIS FOR PROCESSING

Personal data is processed for the following purposes:

Defense in legal proceedings	Art. 6.1.f GDPR - Legitimate interest

*The website does not carry out profiling activities nor send commercial communications or newsletters without the user's explicit consent.*

## 4. COOKIES

For information on cookies used by the website, please refer to the **Cookie Policy** available on the website.

In summary, the website uses only:

- **Technical cookies:** necessary for the proper functioning of the website, no consent required
- **Analytics cookies (anonymized):** for aggregate statistics on website usage

*The website does not use profiling cookies or third-party cookies for advertising purposes.*

## 5. PROCESSING METHODS

Personal data is processed using IT tools, with logic strictly related to the purposes indicated above and in any case ensuring the security and confidentiality of the data.

The Data Controller adopts appropriate technical and organizational security measures, including:



- Hosting on secure servers located in the European Union (Hetzner Online GmbH - Germany)
- HTTPS connection with TLS encryption
- Firewall protection and intrusion prevention systems
- Regular data backups

## 6. DATA DISCLOSURE AND DISSEMINATION

Personal data may be disclosed to:

- **Authorized internal personnel:** employees and collaborators of Valland S.p.A. designated for data processing
- **Hosting provider:** Hetzner Online GmbH (through IdeaTech S.r.l.), for technical website management
- **IT service providers:** for IT system support and maintenance
- **Public authorities:** where required by law

**Personal data will not be disseminated or disclosed to third parties for marketing purposes without your consent.**

## 7. DATA TRANSFER

Personal data is processed and stored on servers located in the European Union (Germany).

No systematic transfers of data to third countries outside the European Economic Area are planned. Should this become necessary, the transfer will be carried out in compliance with the safeguards provided by the GDPR (adequacy decisions, standard contractual clauses, or other appropriate safeguards).

## 8. RETENTION PERIOD

Personal data will be retained for the time strictly necessary to achieve the purposes for which it was collected:

Type of data	Retention period
Browsing data (server logs)	90 days
Information/quote requests	12 months from response, unless business relationship established
Contractual data (if relationship initiated)	10 years from end of relationship

## 9. DATA SUBJECT RIGHTS

As a data subject, you have the right to:

- **Access** (Art. 15 GDPR): obtain confirmation of processing and access your data



- **Rectification** (Art. 16 GDPR): obtain correction of inaccurate data or completion of incomplete data
- **Erasure** (Art. 17 GDPR): obtain deletion of data where applicable conditions are met
- **Restriction** (Art. 18 GDPR): obtain restriction of processing in specified cases
- **Portability** (Art. 20 GDPR): receive data in a structured format and transfer it to another controller
- **Objection** (Art. 21 GDPR): object to processing based on legitimate interest
